The financial statements and much of the financial data are identical in the two documents, but the 10-K report contains more detail (such as schedules showing management remuneration and transactions, a description of material litigation and governmental actions, and elaborations of many financial statement accounts) than the annual report, and the annual report presents additional public relations type material such as colored pictures, charts, graphs, and promotional information about the company.
