Decide to do a 1031 Exchange

You want to upgrade your investment property but not pay capital gains taxes

1



Identify Replacement

You must identify (not buy) potential replacement properties within 45 days of selling your relinquished property

2

Sell Property

Sell your relinquished property then transfer all proceeds to your Qualified Intermediary (QI) while you find a replacement property

3



Buy Replacement

You must close escrow on one of your identified replacement properties within 180 days of selling your relinquished property
