Exercises

- (a) The frequency of $\mathbf{v}_n(\mathbf{f}) = 2\cos(2\pi \cdot 2000\mathbf{f})$ is $2000 \, \text{Hz}$. For this frequency $\mathbf{H}(\mathbf{f}) = 2\angle 60^\circ$. Thus, $\mathbf{V}_{\text{out}} = \mathbf{H}(\mathbf{f})\mathbf{V}_n = 2\angle 60^\circ \times 2\angle 0^\circ = 4\angle 60^\circ$ and we have $\mathbf{v}_{\text{out}}(\mathbf{f}) = 4\cos(2\pi \cdot 2000\mathbf{f} + 60^\circ)$.

 (b) The frequency of $\mathbf{v}_n(\mathbf{f}) = \cos(2\pi \cdot 3000\mathbf{f} 20^\circ)$ is $3000 \, \text{Hz}$. For this frequency $\mathbf{H}(\mathbf{f}) = 0$. Thus, $\mathbf{V}_{\text{out}} = \mathbf{H}(\mathbf{f})\mathbf{V}_n = 0 \times 2\angle 0^\circ = 0$ and we have $\mathbf{v}_{\text{out}}(\mathbf{f}) = 0$.
- The input signal $\mathbf{v}(\mathbf{f}) = 2\cos(2\pi \cdot 500\mathbf{f} + 20^\circ) + 3\cos(2\pi \cdot 1500\mathbf{f})$ has two components with frequencies of 500 Hz and 1500 Hz. For the 500-Hz component we have: $\mathbf{V}_{\text{out,1}} = \mathbf{H}(500)\mathbf{V}_{\text{n}} = 3.5 \angle 15^\circ \times 2 \angle 20^\circ = 7 \angle 35^\circ$

$$\mathbf{v}_{\text{out},1}(t) = 7\cos(2\pi \cdot 500t + 35^{\circ})$$

For the 1500-Hz component:

$$V_{out,2} = H(1500)V_n = 2.5\angle45^{\circ} \times 3\angle0^{\circ} = 7.5\angle45^{\circ}$$

$$v_{\text{out}}(t) = 7.5\cos(2\pi \cdot 1500t + 45)$$
