- "The Council for the regulation of Healthcare Professionals (now known as the Council for Healthcare regulatory Excellence) should be invited to set up a panel of professionals and lay people (similar in nature to the Sentencing Advisory Panel) which should assist in the process of developing the necessary standards, criteria and thresholds (recommendation 56.p 58 and Ch 21 and para 27.230)"
- "There should in the future be a review of the powers of the CRHP/CHRE with a view to ascertaining whether any extension of its powers and functions is necessary to enable it to act effectively to ensure that patients are sufficiently protected by the GMC (recommendation 159 and para 27.283 and Ch 21)"
- "In three to five years' time there should be a thorough review of the operation of the new FTP procedures, to be carried out by an independent organisation. This task should be undertaken by or on the instructions of the CRHP/CHRE) Para 27.307" (R105)
