Key Terms

Article III of the U.S. Constitution creates three branches: the executive branch, the legislative branch, and the judicial branch. The judicial branch is the branch of government that interprets the law and settles disputes. It is the branch of government that is responsible for the interpretation of the Constitution and the laws of the United States.

Supreme Court is the highest court in the United States. It is the final authority on the interpretation of the Constitution and the laws of the United States. It is the only court that can hear cases from all the states and from foreign countries.

Justices are the members of the Supreme Court. They are appointed by the President and confirmed by the Senate. They serve for life.

Chief Justice is the head of the Supreme Court. He or she is appointed by the President and confirmed by the Senate. He or she presides over the Court's proceedings.

Associate Justices are the other members of the Supreme Court. They are appointed by the President and confirmed by the Senate.

Lower Courts are the courts below the Supreme Court. They are also part of the federal judiciary.

State Courts are the courts in each state. They are also part of the federal judiciary.

Appellate Courts are the courts that hear appeals from lower courts.

Trial Courts are the courts that hear cases for the first time.

Jury is a group of people who hear a case and decide the verdict.

Check and Balance is the system of checks and balances that keeps the three branches of government from becoming too powerful. The executive branch can veto laws passed by the legislative branch. The legislative branch can override a veto. The judicial branch can declare laws unconstitutional.
