Circuit: Congress created a system of federal appeals courts Jurisdiction: Article 111 of the Constitution gives federal courts Exclusive Jurisdiction: Which means that only the federal courts may hear and decide cases.

Concurrent Jurisdiction: Under circumstances or instances, however both federal and state courts have jurisdiction, a situation.

Chapter 8, Section 2

District Court: Are the federal courts in which trials are held and lawsuits are begun.
Original Jurisdiction: All federal cases must begin in a district court, the authority to hear cases for the first time.
Appeals Court: Is to review decisions made in lower district courts.

Appellate Jurisdiction: Or the authority of a court to hear a case appealed from a lower court. Remand: The case that is by sending the case back to the lower court to be tried again. Opinion: Offers a detailed explanation of the legal thinking behind the court's decision. Precedent: it gives guidance to other judges by offering a model upon which to base their own decisions on similar cases

Chapter 8, Section 3

Judicial Review: The court can review any federal, state or local law or action to see if it is constitutional.

Constitutional: If the court decides a law is unconstitutional it has the power to nullify or cancel that law or action.

Docket: A court's calendar, showing the schedule of cases it is to hear Brief: A written document explaining the position of one side or the other in a case
