CHANGES IN RATE OF TAX UNDER SERVICE TAX ACT 2018

Effective from 01 March 2024, the rate of service tax under the Service Tax Act 2018 is increased from 6 % to 8% on all taxable services excluding food & beverage services, telecommunication services, provision of parking spaces services and logistics services. Credit card and charge card services remain at a specific rate of RM25/year.
