These barriers are now breaking down for two principal reasons. First, institutional investors, particularly in the United States, have become increasingly interested in European funds. Second, many international private equity firms have become more active in Europe. A second driver of growth has been the entry of new talent into the industry. Traditionally, many European private equity investors had come from financial or consulting backgrounds rather than from operating roles.
