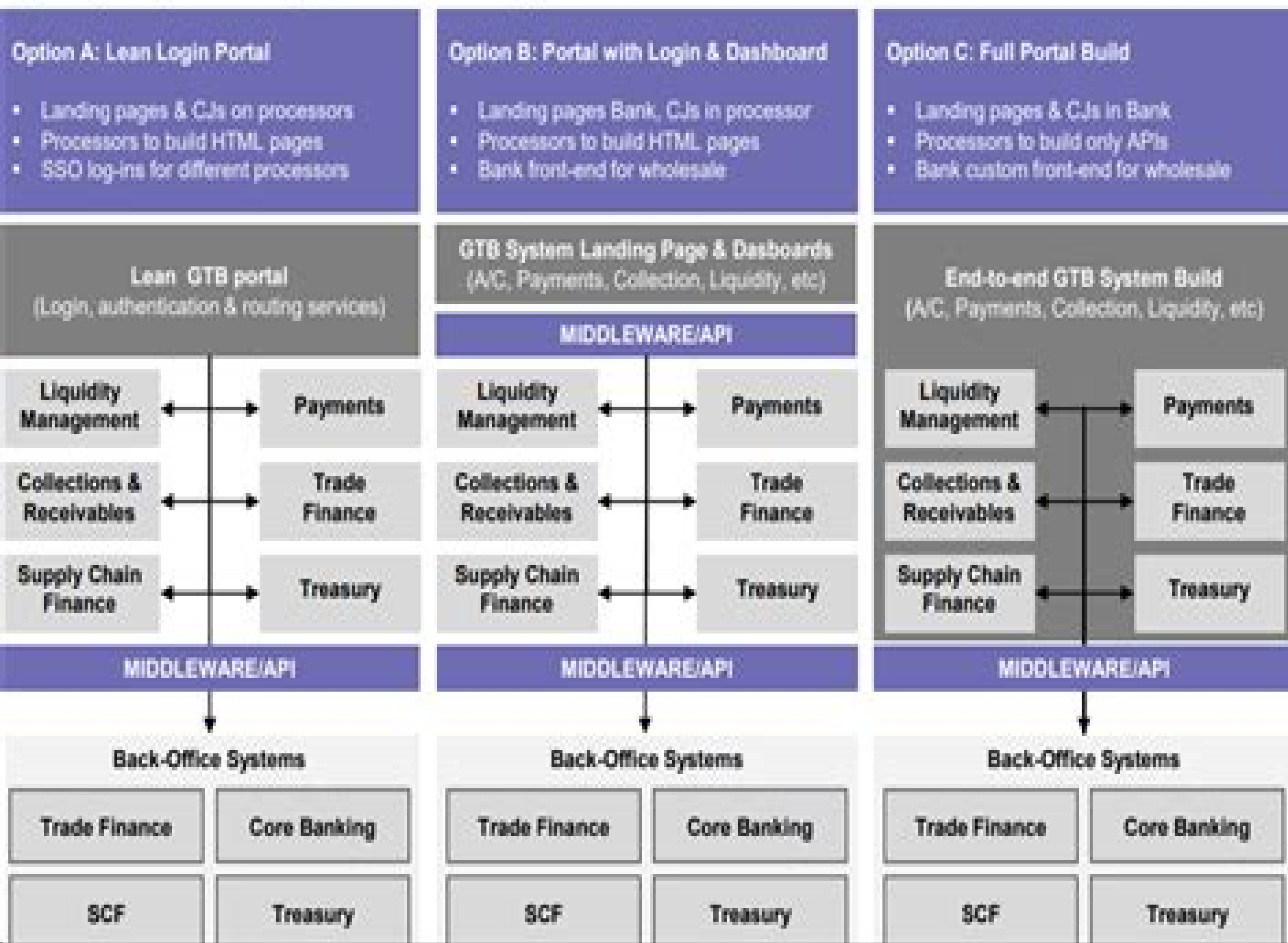


Fig. 1: 3 typical options to build your transaction banking platform
